## Fall 2025 Co-ops ENGR 400 Registration & Requirements

ENGR 400 combines academic study with relevant work experience. It is an optional course available to undergraduate College of Engineering (CoE) students as early as the second semester of their first year. This course carries 0 credit and serves as a placeholder for full-time enrollment while students work full-time during a cooperative education experience (co-op). Enrollment must coincide with the term associated with the dates of the co-op assignment. To be eligible, the student must have a GPA of 2.75 or higher, the co-op job duties must relate to the student's major, and the student must work 30 to 40 hours per week for a minimum of 6 weeks. The fee is currently \$216.19 for each term but may change based on tuition rates for the upcoming academic year which are approved in June. **This course is not available to students requiring CPT.** 

## Application Materials & Enrollment (before your co-op)

Requirements to apply for ENGR 400:

- 1) Attend one ENGR 400 CoE Co-op Seminar (see Career Forge Events section for Seminar times)
- 2) Complete the application in <u>Career Forge</u> and upload the following documents:
  - a) Offer Letter from the employer that must include the following details:
    - i) Job Title
    - ii) Assignment Details including job responsibilities and location
    - iii) # of hours per week
    - iv) Start/End Dates
  - b) Degree Plan/Academic Advisor Approval Form (signed by Academic Advisor)
  - c) Initial Essay (prompts in syllabus provided during Seminar)

## *Instructions to apply:*

- 1) Log into your <u>Career Forge</u> account
- 2) Select 'Experiences'
- 3) Click 'Add Experience'
- 4) Follow prompts to submit all documents

You will not be registered for ENGR 400 until you have attended the required Seminar, have submitted all of the requirements listed above via <u>Career Forge</u>, and your application is approved by the ECRC. You will receive an email confirming your registration in ENGR 400 from the ECRC. Incomplete registration or missing documents will delay your enrollment into ENGR 400.

Note: If you are already registered for classes during an academic term and accept a co-op, you must notify the ECRC at coe-intern-coop@umich.edu as you will be withdrawn from your classes. You must receive permission from the ECRC to take classes (virtual or in-person) during your co-op assignment.

### **ITS Account**

While on your co-op assignment, your U-M Google email (@umich.edu) will remain active. Access to the files stored in your CAEN Account will also remain active, however CAEN computer labs may not be available during this time.
